"The young professionals accounted for a large majority of the


research submitted, and in my opinion, these young practitioners are the ones that will be carrying podiatric medicine and surgery into the future," says Dr. Mulhern.

foot and ankle since it's only been thoroughly documented in the



PPMA Proposes Benchmarks for Declining Student Applicant Pool

As most of your know, the APMA House of Delegates is coming up in a few weeks. Historically, Pennsylvania has submitted Resolutions on various issues pertaining to the profession of podiatry, its practice, or its place in the medical industry in which we all now labor. This year, we have focused on what the Board feels is the most important issue that we all face, and that is the declining number of applicants in the student pool. As I write this column in late February, we have less than 500 applicants for positions in our nine schools. Our Board saw this trend last year and took a Resolution to the House, asking that the APMA produce a "Plan," which would show the steps necessary to grow the profession of podiatry.

Through the political processes of the House, that Resolution was amended to state the following:

"RESOLVED, That the American Podiatric Medical Association (APMA) work with the Balance Committee of the American Association of Colleges of Podiatric Medicine (AACPM), the Council on Podiatric Medical Education (CPME), and the National Board of Podiatric Medical Examiners (NBPME), the American Podiatric Medical Students' Association (APMSA), and other appropriate entities toward the development of an Action Plan to Coordinate Career Awareness and Career Promotion to promote the continued growth of the profession through: 1. An increase in the number of qualified podiatric student applicant pool, and 2. An increase in podiatric school enrollment, and 3. An appropriate balance in the ratio between the number of graduating doctors and the number of residency positions available; and RESOLVED, That said preliminary steps to establish said action plan and benchmarks necessary to achieve said plan shall be taken within six months from the date of this 2017 House of Delegates, with drafting and publication of said plan to take place within nine months from the date of this 2017 House of Delegates, and a report made to the House of Delegates in 2018."

The amendment of this Resolution placed the responsibility of the creation of a "Plan" in the hands of the American Association of Colleges of Podiatric Medicine (AACPM). The rationale

behind this amendment was that the Balance Committee of the AACPM was already working on these issues. The result, to date, of this amendment was that the AACPM has issued an interim report stating that the interested parties should keep on doing what they have been doing, and that the "aggregate" number of licensed podiatrists in the nation has grown over the past few years.

This interim report fails to reconcile its statement that the profession is growing, given the following facts—

- The number of applicants to the schools has dropped;
- The number of students the schools may take in has been "capped" by the CPME due to the availability of residency positions:
- There are a substantial number of our schools that did not fill their class openings over the past two years; and
- The failure to graduate a sufficient number of students to occupy available residency slots will result in the loss of those slots.

Given this response to a request for a viable plan that enumerates the steps that must be taken to produce growth within the profession, our Board has submitted two Resolutions for this year.

The first is a very simple Resolution highlighting the problem of a decrease in prospective students and making the following Resolve:

"RESOLVED, That the American Podiatric Medical Association (APMA) immediately dedicate such 13 resources and personnel as it deems necessary to increase the number of qualified applicants to 14 podiatric medical schools."

The second is more involved. It makes the same request that we made last year; that is, the APMA work to produce a plan that outlines the steps that must be taken in order to show a growth in the profession of podiatric medicine. "A Plan for Growth" must, by its nature, involve an investigation into and evaluation of the various factors affecting our profession negatively. This is not just trying to increase student enrollment. It must be a deeper analysis. We



knee and hip. "We are seeing it more and more in our office, and we are now using a treatment protocol that is standard across the board like the one I discussed in the poster—nonweight-bearing for 6-8 weeks, followed by protected weight-bearing for an additional 4-6 weeks," she says.

It was due to the rare nature of this topic that Dr. Godoy chose it for her poster, and it paid off. Also the topic interested her, and when the office had two patients with similar presentations, ruling out all other etiologies, BMES was the answer. This gave her what she needed to formulate her poster for the competition.

When asked if she would do anything differently when she does another poster competition, "I don't think I would do anything differently. ... I also feel that the topic was easily understood by everyone in the profession, regardless if they were surgical or not." She is currently working on the early stages of a poster on "The Rotational Component to Hallux Valgus Deformities," which was accepted for another conference poster abstract competition.

Heidi Godoy, DPM, is in her third year of residency at Geisinger Community Medical Center, Scranton, PA. She will finish this June and plans to head back to her home state of New Jersey for an associate position with New Jersey Foot & Ankle Center (NJFAC).

FISH SKIN GRAFTS COMPARISON

Christopher Winters, DPM, won second place in the Scientific Division for his poster, "Fish Skin Grafts, Amnion Membrane, Human Cadaver Skin and Mammalian Tissue-Based Products: Comparison of Structure, Lipid Content, and Cellular Interactions." Dr. Winters says that when he returned from a family trip to Iceland in 2013 and then upon reading a medical journal article in 2014 that discussed the use of fish skin on diabetic ulcers, he was hooked (no pun intended). Afterwards he contacted the company, and he used "the product on several patients and got amazing results with rapid decrease in size of the diabetic foot ulcers and significantly shorter healing times compared to other currently available products on the market at the time."

Since that time, Dr. Winters has continued to use fish skin for the last four years with continued success to heal difficult-to-treat, lower extremity ulcers of many different types. He says this novel technique that uses a renewable resource is what made his poster a winner. "It has been shown that the lipid content in the fish skin is high, which helps with the anti-inflammatory process in chronic wounds," he says.

The poster's findings:

- The structure of the fish skin is similar in pore size to human skin, which allows the human cells to potentially recognize the fish skin as human.
- This allows the cells to migrate easily into the fish skin.
- It also shows increased cellular infiltration of the fish skin in comparison to human cadaver skin and other mammalian tissue-based products.
- So with the similar pore size allowing cells to migrate in quicker and the omega-3 lipid content of the fish skin, we have shown increased cellular migration into the fish skin thus leading to more rapid healing times in the wound. For those considering to enter a poster competition, Dr.



Winters stresses if working with wounds to keep track of healing rates and to put together a small study of five to 10 patients; follow them for 12–16 weeks; then at 6 or 12 months if possible. Keep up with photographing the progression, arranging all the information, and getting help from a resident if possible. This he says ultimately will lead to publication in a peer reviewed journal.

Dr. Winters specializes in the diabetic foot and wound care. He is podiatric residency director, Podiatry Residency Program, at St. Vincent Hospital in Indianapolis, Indiana. He's currently Chairman of the American College of Clinical Wound Specialists, and has lectured nationally and internationally on wound care. Dr. Winters is in his nineteenth year at The American Health Network group of physicians in Indianapolis.

STATE ASSOCIATION ADOPTION OF TWITTER—WHERE ARE WE?


Third-place winner in the Scientific Division was Christopher Hood, Jr., DPM, for his poster on, "Podiatric State Association Adoption of Twitter—Where Are We?" This unique poster exam-

ined how each of the podiatric associations from the 50 states, including DC and Puerto Rico, utilize Twitter, with a further review of what other social media platforms were used; such as Facebook, Instagram, LinkedIn, Pinterest, YouTube, and Vimeo. "Only 14 of the 50 states, plus the District of Columbia, had active Twitter accounts at the time of publication," says Dr. Hood. His other findings:

- The majority of the states that did not have Twitter accounts also did not have any other Social Media (SM) platforms listed on their association websites, whether on the homepage or other pages (e.g., "Contact Us," "About Us").
- Of the associations with a Twitter account, Facebook was the overwhelming other method of SM presence.
- Overall, this exercise demonstrated there is a relative lack of state association involvement in social and digital media platforms; and the poster gives various methods to help increase social media utilization and awareness.

Dr. Hood's inspiration came from attending the 2017 House of Delegates meeting last June when PPMA's Board introduced its new Twitter account (@PPMAssoc). "I found it interesting that in 2017 they were just starting to use Twitter," he says. This made him curious to find out how many other similar associations already had Twitter accounts, and how far Pennsylvania trailed behind.

As it turned out Pennsylvania was actually ahead of the game compared to the rest of the associations. Dr. Hood says he



attempts at least to do one poster on social/digital media, marketing, etc., out of every three or four. "I'd like to think it helps people in our field think outside the box or recognize areas they can assist their practice or society," says Dr. Hood. The examples he gave include posters looking at Twitter hashtag use at podiatry/foot-ankle conferences; and trends in referrals to podiatric surgeons, i.e., personal versus social/digital media referral sources.

Dr. Hood was actually part of five entries in this poster competition, including one that received First Place in the Scientific Division for Sneha Patel, DPM, who was the primary author for the poster, "A Retrospective Multicenter Review Evaluating the Safety of Utilizing Fiberglass Total Contact Casts

in Hyperbaric Oxygen Chambers."

He also entered in the Scientific Division, "Defining Talar Head and Neck Pathology: The Malvern Classification System." The concept initially was an office back-hall chat that turned into a multi-year project culminating into a five-part classification system and recently published in the *Journal of Foot and Ankle Surgery* (JFAS. 2018; 57(1): 131-139. PubMed ID—28843549). "The system's name is a dedication to the location of our practice's primary office in Malvern, PA," says Dr. Hood.

Dr. Hood is an Associate, Dept. of Foot and Ankle Surgery, for Premier Orthopaedics and Sports Medicine/PA Orthopaedic Center Division. He received the Outstanding Poster Abstract Award, Resident Category–First Place, APMA National Meeting, July 2016, Philadelphia, PA. He's an Associate member of the ACFAS and is Board Qualified with the American Board of Foot and Ankle Surgeons. **UPDATE**

Response to 10 Common Incidents of Non-Paying Patients, 1-5

- 1. "Why do I have to pay a co-payment (or fee for office visit) if I only spoke to the doctor? I mean, he didn't do anything."
- 2. "I went to get a second opinion and different information was given to me. I do not feel I have to pay my balance."

RESPONSE: In either case, educate your patient—*A* consultation where the doctor discusses medical advice, a

treatment plan and/or recommendations is considered an office visit. According to your insurance card, you agreed and are responsible to pay a [\$xx.xx] co-pay at each office visit; as well as an annual deductible any time you are scheduled to see the doctor. Since you were seen in our office on [date] and we do participate in your plan, we are responsible to collect that co-pay/balance from you. NOT collecting that fee puts both of us in violation of your contract. Will you be paying that by cash, credit card, or check?

3. I forgot my wallet.

RESPONSE: The question you want to ask yourself is does this happen on a regular basis, or is it a one-time occurrence? That should make a difference how you respond—One time occurrence: Oh, sometimes those things happen, Mr. Jones. I can call you later today and you can just give me your credit card number over the phone so I can process your payment and avoid sending you a statement. Your financial policy should dictate what occurs for repeat offenders.

4. I have an accountant that handles all my bills.

RESPONSE: Take this opportunity to review your financial policy with the patient, and his/her agreement by signature, indicating that payment is required at the time of service. You might even want to give them another copy and suggest they present it to their accountant—We try very hard to avoid sending out statements and that time savings allows us to give more of our attention to our patients. We do accept credit card payments, and in fact that method of payment will actually allow your accountant

to effectively consolidate your charges and better manage your money matters. I'm happy to take your credit card number now and, if HIPAA security measures are in place, keep your number on file for future visits.

5. Can you send me a bill? I cannot pay my balance today.

RESPONSE (if co-pay, see #1): As noted on your insurance card, your co-pays are due at the time of service; and as we are contracted with your insurance company, we are responsible to collect it. Note: This is why I recommend collecting co-pays up front because if patient does not pay, you are not obligated to treat them. If they incur additional expenses while in the treatment room (supplies, services, etc.), collect the additional fee upon discharge.

RESPONSE (if no co-pay, see #4): Will that be cash, credit card, or check? UPDATE

must realistically define our own profession. We must define and determine our role in the medical industry. While we cannot ensure the prosperity of our graduates, we must be able to state that the 4:3 model we've adopted will produce doctors of podiatric medicine. DPMs who will be able to practice on their own, with podiatric groups, with integrated groups, or as employees of health facilities. Without dedicated work on that outcome, we cannot justify to the incoming student that, "Podiatry is the positive and progressive profession that we all know it to be."

We have asked the following: "BE IT RESOLVED that the American Podiatric Medical Association (APMA) take responsibility to create and implement a plan for the Growth of the Profession of Podiatric Medicine, and further that: The APMA appoint a Committee composed of all stakeholders in the profession of podiatric medicine, ... [named entities]... as are necessary to address this issue. Said committee to be charged with the development of an Action Plan to Coordinate Career Awareness and Career Promotion in order to promote the growth of the profession through: 1. An increase in the number of qualified podiatric student applicant pool; and 2. An increase in podiatric school enrollment; and 3. An appropriate balance in the ratio between the number of graduating doctors and the number

of residency positions available."

As with any enterprise, we are asking that the profession establish benchmarks, with the primary goal to demonstrate growth. We have nine delegates and a 1st Alternate this year. We will also have three other Alternates who support the work of the Delegation, and who are interested in "learning the ropes." We solicited the help of the Alternates in that this House will be presented with a number of proposals that would change the nature of the relationship between the House and the Board of Trustees. The proposals, if enacted, would take much of the historic power away from the House in favor of creating a much more centralized Board of Trustees.

With the help of the PPMA Board, I have authored a set of recommendations on all of the proposed bylaw changes. We have posted them on our website (www.PPMA.org); and I ask that you take the time to read and review both the APMA proposals and our review of them. As always, call me or the office with comments or suggestions.

I appreciate all of your support, and I hope that you realize your importance in our efforts to grow and expand our profession. *UPDATE*

PPMA Scholarship Terms & Conditions

ELIGIBILITY: To grant an academic scholarship to a family member of an active member of the Pennsylvania Podiatric Medical Association (PPMA) whose professional liability insurance is supplied through the Podiatric Medical Assurance of Pennsylvania (PMAP) program. The grant shall be used by the family member to offset costs incurred to attend an accredited 4-year college, an accredited two-year college or an accredited trade school.

AMOUNT: This amount shall be determined annually at the House of Delegates of the Pennsylvania Podiatric Medical Association and shall be no less than \$500.00 per year (for a period of up to four consecutive years). The amount may be changed from time to time in order to reflect support of this scholarship by related parties whose generosity shall be demonstrated through an increase in this grant amount.

TERMINATION OF SCHOLARSHIP BY PPMA BOARD: This is not an endowed scholarship grant, and its existence can be terminated at any time by the Board of the Pennsylvania Podiatric Medical Association. It is the intent of the Board, as composed at the time of the creation of this scholarship, to continue the granted amount through the academic tenure of the recipients for a period of up to four years. However, should this scholarship be discontinued, the Board, as then composed at the time of any termination, shall make the decision and continue or discontinue any outstanding grant in light of the financial condition of the Association. At that time, the Board shall have the power to terminate the scholarship outright, with no further grant obligations or continue it for the tenure of any recipient then having received a grant.

DURATION: This grant may be made for a single year or for the applicable term of higher education entered into by the family member of a qualifying PPMA member. The discretion shall be within the Board of the Association. If it is continued for a period of more than one year, annual evidence of satisfactory participation in the academic program of the recipient shall be required as a condition of continued support of this grant.

SCHOLARSHIP COMMITTEE: The decision on a Scholarship grant shall be made by a Scholarship Committee appointed by the President of the PPMA Board annually. That committee shall request a Resolution of the Board in order to finance the amounts to be granted annually. No grant shall be valid unless and until it is noted in a Resolution duly made and passed at a regularly scheduled meeting of the Board of the Pennsylvania Podiatric Medical Association.

ADVERTISING: The existence of this scholarship shall be advertised regularly in the Association newsletter. In addition, the Scholarship shall be listed as a Benefit in the list of membership benefits available to all members who qualify. All advertisements shall list the requirement of participation in the Podiatric Medical Assurance of Pennsylvania program, as well as dates for submission of application.

"Even though at first glance podiatry seems to just involve a seemingly small body part, it is a very diverse and dynamic profession."

1. What are some of your main attributes that you bring to the profession of podiatry?

One of the main attributes I bring to the podiatric profession is a fresh athletic training and sports medicine perspective. Before podiatry school, I majored in athletic training and became a Certified Athletic Trainer. I had an interest and passion for sports medicine since I met my athletic trainer in high school. When patients ask me, "Don't you get tired of looking at feet all day?" I always respond somewhere along the lines of, "No, because so many different things can go wrong with the feet and ankles!" Something I would like to change would be the fact that a lot of people have no idea what podiatry is and don't know what education and training is needed to become a podiatrist.

4. Why do you feel membership in PPMA, and APMA, is vital to you?

For me, PPMA and APMA membership is vital so that I can utilize all the resources available for practice management, patient education, marketing, billing/coding, and to learn about the problems facing the profession. I also feel it is very important to be engaged and involved in the community. In order to help grow the profession, we all need to be involved and aware

of the issues. I feel the first step to accomplishing our goals is to become a member of the organization.

5. Anything else you want to add—your accomplishments, your future plans?

My first year out of residency I joined and took over the practice of a gradually retiring physician. This was no small feat. I am proud to be a young female practice owner. As I am learning how to practice post-residency, I am also learning how to run a profitable business. My goals and plans for the near future involve continuing to build and grow the practice. My 5–10 year goal is to grow the practice enough to hire an associate. Our practice currently works with athletes from two universities as well as local recreational athletes and runners. I hope to continue to grow the sports medicine aspect of my practice.
